

WHO'S WHO in E&P A&D 2017

Back To The Days of Deals

E&Ps started off 2017 with the kind of whirlwind of deals that took us back to pre-2014 goodness.

To start the year, ExxonMobil barnstormed the Permian Basin in New Mexico in a deal for \$6.6 billion. In February, Parsley Energy Inc.



bought Midland Basin assets from Double Eagle Energy and affiliates for \$2.8 billion.

In April, Hilcorp Energy Co. agreed to a \$3 billion purchase of ConocoPhillips' San Juan Basin assets covering 1.3 million acres in New Mexico and Colorado.

By the second quarter, sellers increasingly looked to rationalize their portfolios. Occidental Petroleum Corp. sold to Halcon; Chesapeake closed two deals in the first half to sell noncore assets in the Haynesville.

Halcon was among the most prolific buyers, with four deals announced or closed in the first half of 2017. Meanwhile, Linn Energy, abandoned assets it no longer saw as long-term benefits for the company in four separate sales.

In your hands is a tool to connect to those big E&Ps—and the microcap companies, too—that may be divesting a puzzle piece that opens up your lateral running room or helps you block up a section. For nearly all of the E&Ps mentioned above, this publication contains a direct line or email to decision makers and A&D teams at companies of all sizes.

Foremost, the 2017 Who's Who in E&P A&D is a guidebook for you and your colleagues. It contains roughly 500 A&D professionals representing hundreds of companies.

In it you will find 110 president and CEOs; 140 vice presidents, senior vice presidents and land and acquisitions managers; and roughly 90 A&D and BD specialists who are the gateways to possible deals.

In our efforts to create this directory, we also found harbingers of the Great Crew Change: 11 retired. And, sadly, we learned earlier this year that Theo B. Bean Jr. passed away on June 12. Bean, the president and CEO of Bean Resources, prided himself on being able to "outwork" anyone, according to his obituary. He was a longtime presence in this directory.

We want to acknowledge your help in creating this directory. Each year, you take the time and effort to update us with your current information. I sincerely thank you.
