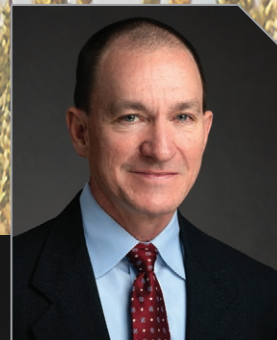

Even at its bleakest, and 2020 has been bleak, oil and gas deals have somehow managed to push through. That's simply the resilience of the A&D crowd and the realization that amid the distress and bankruptcy to come, deals have to get done.

The COVID-19 pandemic has fouled up plans for expansion, consolidation and exits. But as truly as misery loves company, deals get done in downturns. But dealmakers remain vibrant and ready to pull the trigger even as the first half of 2020 ranks among the worst for the oil and gas industry in decades.

The long-running Who's Who in E&P A&D continues to feature the women and men at the center of the deal universe and an insider's preview of what E&Ps are buying and selling.

As always, may you have good fortune and great deals.

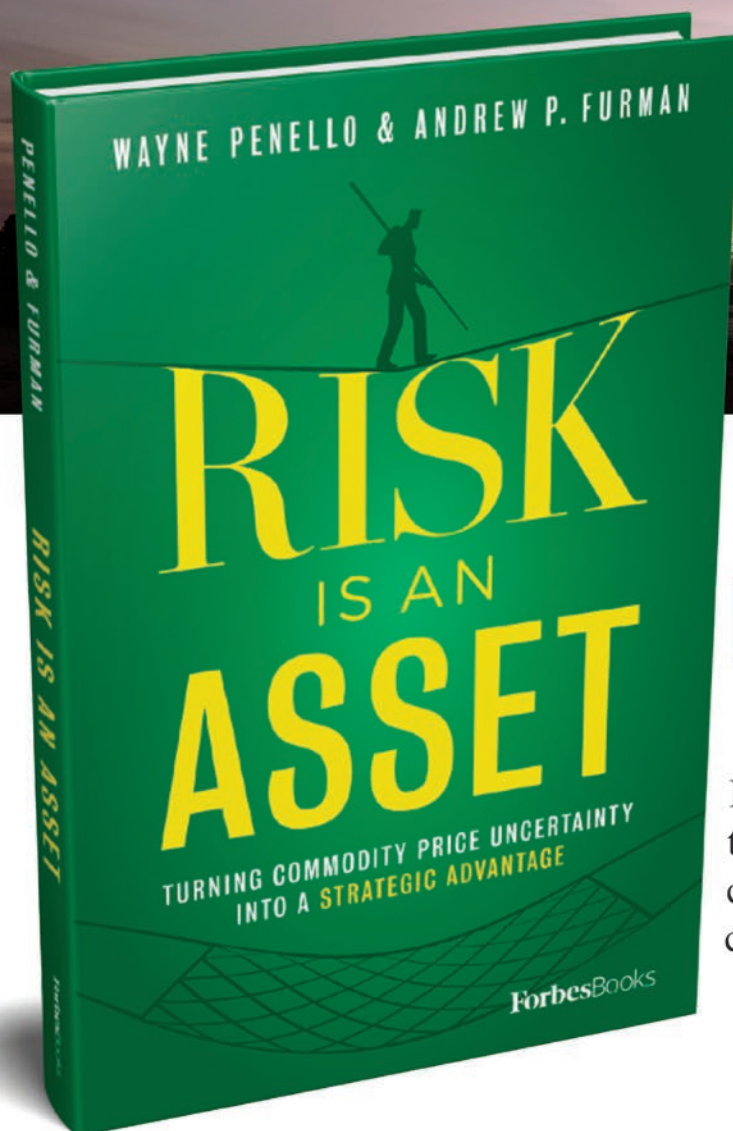
